

THE BACKGROUND

Data Connect's client is a major academic department in a world-renowned university in the UK, successful for their collaboration between academia, the public and private sectors. The group has established an enviable reputation for driving innovation in science, technology and engineering within research and industry.





How Data Connect helped a university department to fuel its growth by gaining access to major contract opportunities.

As part of its growth strategy, the group identified the critical need to attain Cyber Essentials accreditation, which is increasingly becoming a mandatory requirement for both funding and significant new-tender opportunities.

CHALLENGE

Arguably, the biggest challenge for the group was scoping Cyber Essentials to ensure it met the specific regulatory requirements mandated to provide robust protection against cyber threats and to elevate the group's position to gain access to significant growth opportunities.



THE SOLUTION

After an initial consultation to establish the group's objectives, Data Connect provided access to its portal. This contained questionnaires about the organisation's current security profile and ambitions.
