THE HIGHLIGHTS



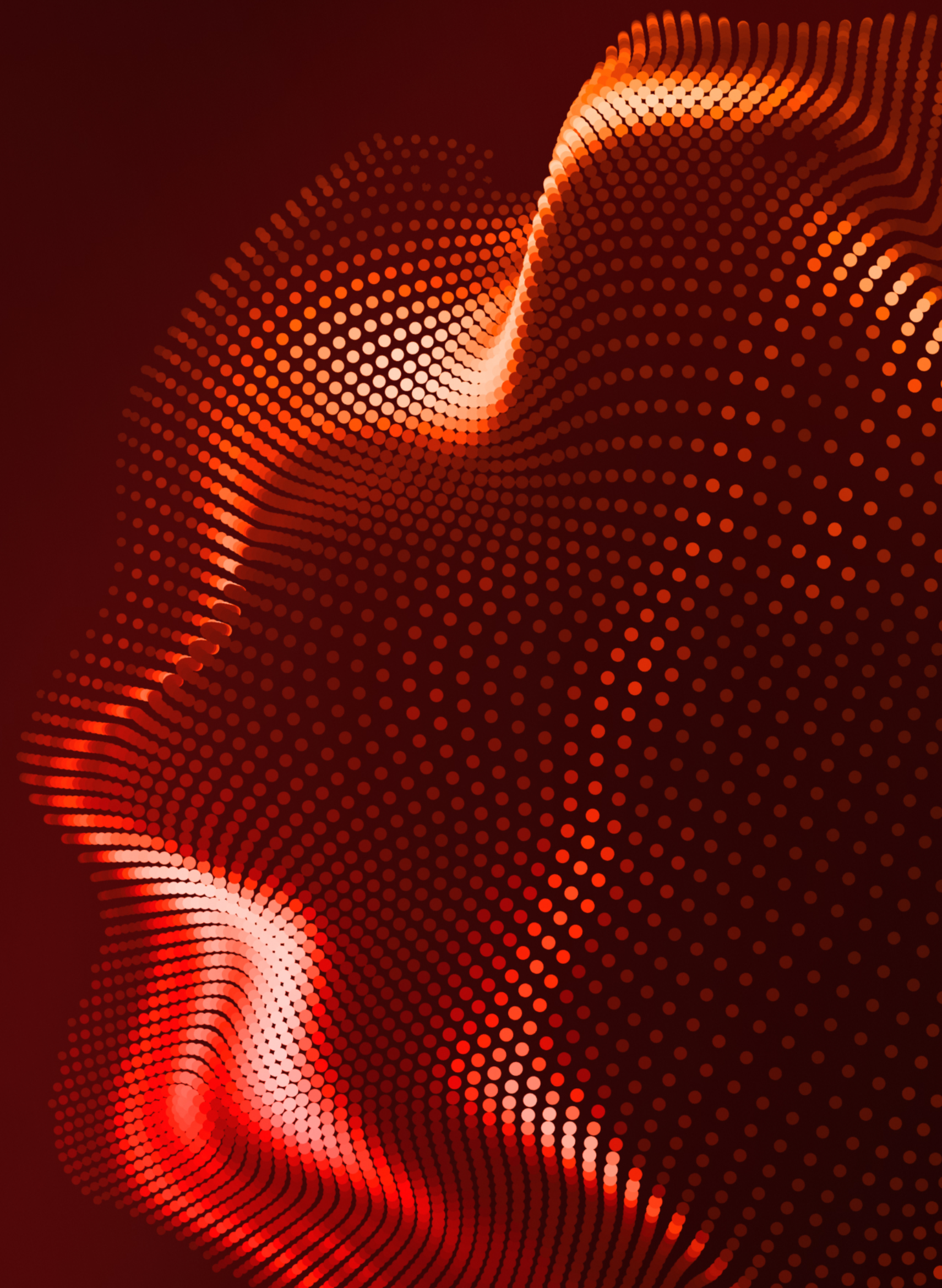
Challenge

As a company that's expanded over the years through acquisition, the overarching challenge facing the business was bringing together all legacy systems and existing solutions across their entire estate. They then needed an effective patching strategy, as like many companies going for Cyber Essentials, they struggled with visibility and patching.



Solution

The client signed up for Data Connect's vSOC CERT Gold+ service, which delivers a single view of vulnerabilities with high and critical severity scores. This allows users across the estate to identify and patch existing or emerging threats to the business's infrastructure in a 14-day timeframe, which is a requirement for Cyber Essentials compliance.





Results

A clear overview of the business' systems has been delivered, and remediation has been greatly simplified to standardise vulnerability management across the network and ensure smooth recertification, year after year. This in turn has supported positive tendering outcomes and helped fuel the business's growth. The client elaborated:

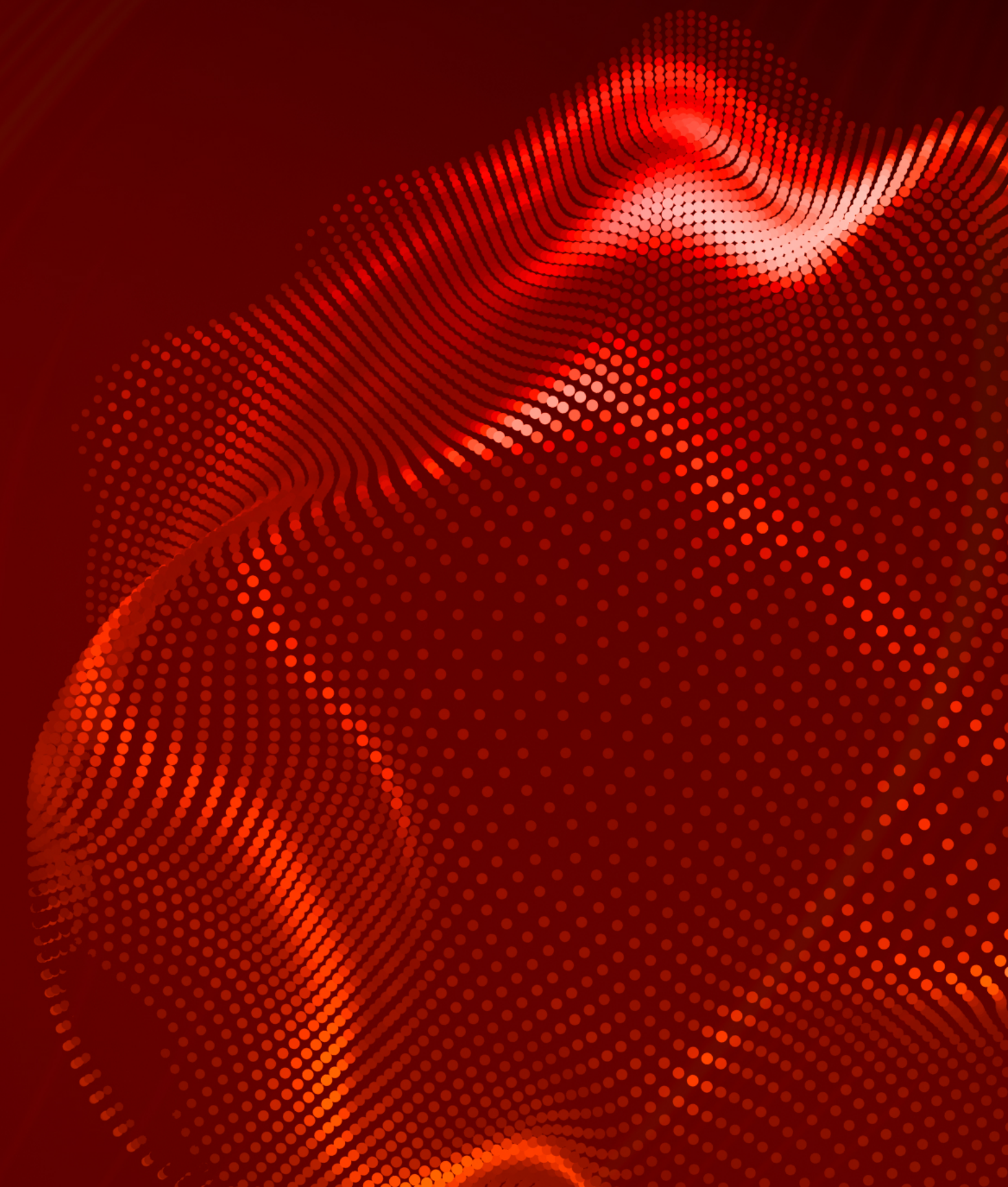

THE BACKGROUND

Data Connect's client is a leading healthcare company that manufactures hospital equipment in the UK for use in both public and private hospitals and care homes. The origins of the business stretch back over 100 years, and since it was originally established, it's grown through acquisitions and mergers, becoming one of the leading international names in the sector, with offices all over the globe. The business produces a wide range of products, including hospital beds, and it also imports a range of vital equipment, including oxygen concentrators.

THE CHALLENGE

It needed to ensure it was meeting the required level of compliance across the network in order to maintain its Cyber Essentials Plus certification – a key requirement for the significant public and private contract opportunities it wanted to bid for.

THE SOLUTION

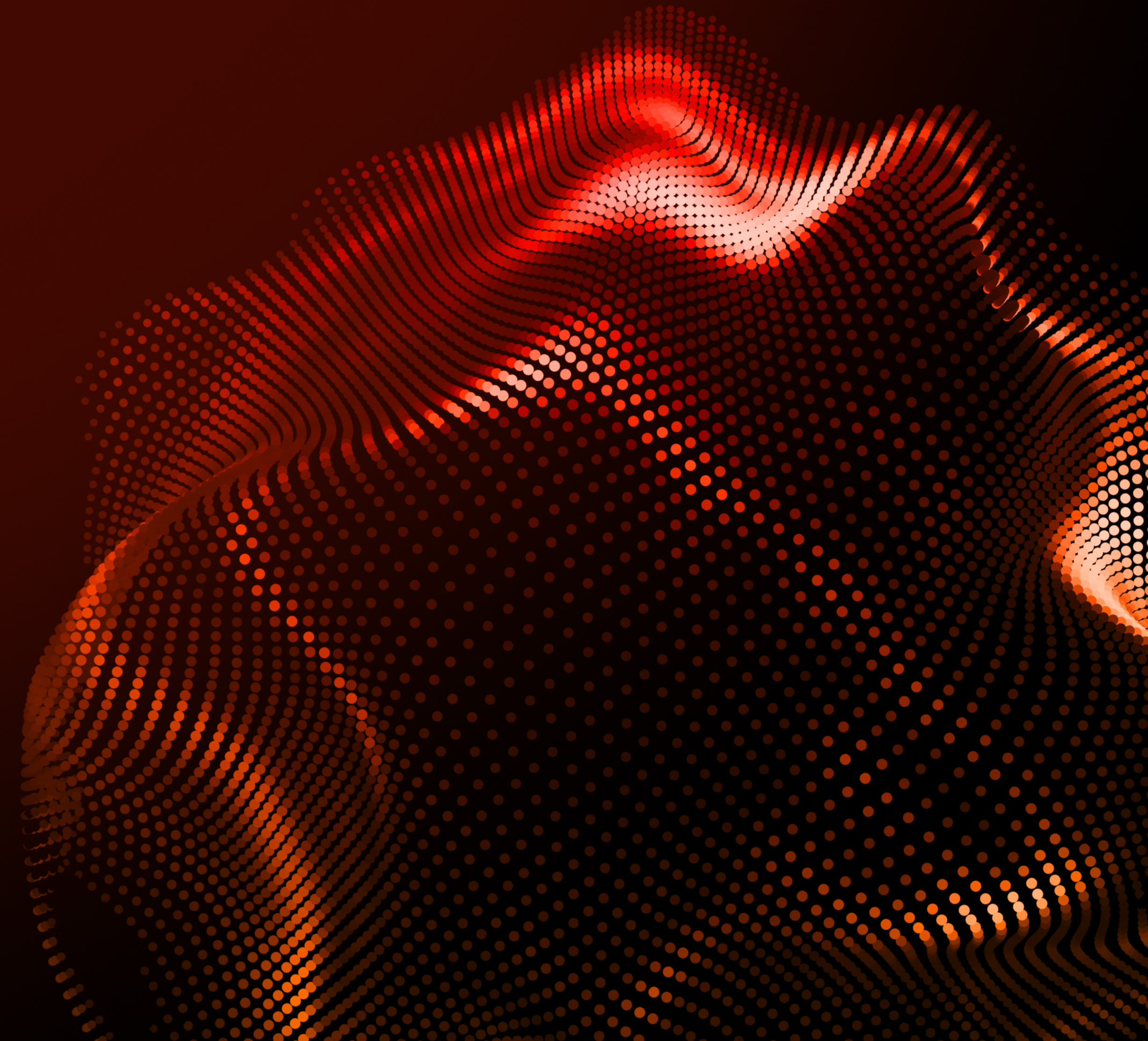
